Our duty and responsibility as the council (also the city planner and the planning and zoning commission) is to make sure that lawful and legal practice of the code and standards is fairly applied to all. Because you may not agree with the change does not mean that it was done illegally. 3) The city is not going bankrupt. We are in great financial shape. By law we are audited every year and have financial reports to show a history of our overall standing. 4) We are not running out of water. We have water in the aquifers and the rights to take water out of the aquifers via the wells that we own. All of our water rights must stay here in Elk Ridge. It is against the state constitution to transfer rights from our city. We have not and can not sell them to anyone else. We have extra water rights that can be assigned to homes by use of a cashin-leu-of policy. What that means is, if you build a home and you don't bring transferable water rights with you, we will assign some of our extra water rights to your development in exchange for cash. We do not give water to anyone.

I am always shocked and amazed at the amount of misinformation that gets to my office. I can only surmise that it comes from people who either don't understand the issues or they get great pleasure in rumors and do not care if it is true or not.

My purpose has not been to cause offense but to state the facts and encourage you to be an active voter and to know the truth and make an effort to sustain it. Yet I have found that the positions of Mayor, Council and Planning Commissioner are accused of things that are simply not true and I will call out any of the lies and false rumors that continue to have an effect on this community. All of you deserve to know the truth and to know that this present council, planning commission and office staff does its best for you.


