

ORDINANCE NO. 23-02

IN ORDINANCE AMENDING THE CITY OF ELK RIDGE MOTOR VEHICLES AND TRAFFIC SNOW REMOVAL 6-1-5, CORRECTION OF SCRIVENER'S ERRORS, SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Elk Ridge has adopted the Elk Ridge City Motor Vehicles and Traffic, Snow Removal 6-1-5; and

WHEREAS, the Elk Ridge City held a public meeting on _____, 2023 at 7:00pm, for the purpose of the proposed amendment to Motor Vehicles and Traffic, Snow Removal 6-1-5; and

WHEREAS, the public meeting was preceded by the posting of a notice of public meeting in at least to the Payson Chronicle Newspaper, a newspaper of general circulation within the city, the Utah Public Access and the city website at least 24 hours prior to the Public Meeting; and

WHEREAS, the notice of the meeting, which was posted and published, by the City Council contains specific advance notice that the proposed ordinance amendment, as set forth herein, would be considered and that copies thereof were available for inspection in the city ' offices; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF ELK RIDGE CITY, UTAH, AS FOLLOWS: (red text is added text, ~~strikeout-text is deleted text~~)

6-1-5: SNOW REMOVAL:

- A. Parking Prohibited For Snow Removal: In order to facilitate efficient and safe removal of snow from city streets, it is unlawful for the owner or driver of any motorized or nonmotorized vehicle, trailer, boat, or other transportation device, to be parked on the street or within **city right of way** during snow removal activities ~~between November 1 and March 1~~. Any vehicle that is parked in violation of this section may, without prior notice, be removed immediately at the owner's expense.
- B. **Placing or Pushing Snow Upon any City Street or property is Prohibited: It is unlawful for any person removing snow or ice from a sidewalk or driveway to place or deposit said snow upon any city street or property. It is unlawful to push snow or ice across any city street or property. Violation of this code can result in fines and citations.**
