Chris Hermansen, owner of the Elk Ridge Assisted Living stated he is selling the few feet that adjoin his property and the neighboring 20 property owned by the Clayson's. This has all been a frustrating process. He thought he could just quit claim it to the Clayson's, but he 21 was told by the city that he couldn't do it that way. He didn't know the laws. If he had known how much it was going to cost, he would 22 23 not have sold it. The property has already been rezoned. He had to fix a retention basin that is required for his property. He has the engineering worked out for that basin now and he has to put in a fence and the approval of the city engineer of what needs to be done for 24 25 the basin. 26 There were no other comments. 27 Maureen Bushman closed the public hearing. 28 29 **ACTION ITEMS** 30 Maureen Bushman reviewed the city engineering report with the planning commission. Ron Gailey recommended making the approval conditional upon the basin and fencing be put in place. 31 32 MELANIE PAXTON MOTIONED TO RECOMMENDED APPROVAL OF THE CLAYSON SUBDIVISION BASED ON THE 33 ENGINEERING REPORT AND ALL CONDITIONS SET BY THE ENGINEER MUST BE MET RON GAILEY SECONDED 34 35 VOTE 36 AYE (4) NAY (0) ALL APPROVED Absent - Matt Stewart 37 **GENERAL PLAN DISCUSSION** 38 39 Maureen Bushman stated the planning commission has been working on the parks and open spaces. Shawn Eliot is working on updating 40 all the maps which will be ready for the next meeting. Ron Hill worked on simplifying the language which is in yellow. Ron Gailey stated 41 if parks are not being used maybe it is because they are not functional and may need to be rethought. Maureen Bushman stated there are grants available for parks and to improve what the city has besides building new parks and the city needs an overall specific long-range 42 plan. Melanie Paxton read the feedback on the grant submitted for trails and the most important factor was the specifics on what the 43 44 project is and the overall plan. There is a grant writer at Jones and DeMille and MAG also has grant writers that could help. Ron Hill stated not only does the general plan need what type of park but how to get the funding. Discussion ensued on whether the sports section 45 belonged in the general plan and was ultimately decided to keep it in the general plan. Does the city want to keep 5 acres per 1000 people 46 47 as the city standard? Ron Gailey stated that if the city does not designate space for open space or parks the land and opportunity will 48 disappear. Discussion ensued on specific types of parks such as dog park, splash pad using recycled water, multi-use sports courts, soccer 49 fields, etc.

Melanie Paxton recommended adding a new designation of "natural trail" as a new category, moving the trail below the roundabout to the east side of Elk Ridge drive to meet the future trail coming up from Salem. The trail around Shuler Park, not the track, designate as a

that crosses the street there has to be a striped street crossing. Loafer Canyon is treacherous; there is no room on the east side of the road

natural trail. The Call-to-Action Section should include maintenance such as repainting the striping on roads. Whenever there is a trail
