HANSON LOT 70A SUBDIVISION 21 Maureen Bushman opened the public hearing. 22 Diane Shultz stated this isn't about the subdivision. She had questions concerning some things in general. She 23 did not realize when taking the survey that trails meant sidewalks and would like to change her response to 24 absolutely uninterested in trails. Her questions were, are the trails for the CE3 area or for the whole city? What 25 does the statement in the general plan mean by "working with private landowners? What is a divided trail, what 26 kind of surface would the trails be? Would they be on one side of the road or both? Would the new extension 27 have a trail? Some of the directions on the map do not make any sense. Some older areas do not have sidewalks, 28 how is that going to impact those residents, and will it look good? What is the vision for those that do not have 29 infrastructure? There is nothing concrete in the general plan. 30 Ron Gailey entered the meeting 31 Maureen Bushman stated the plan is not to disrupt or take away from the residents but to improve the city and 32 suggested for residents to read the General Plan and come to meetings and email any questions or concerns to 33 the Planning Commission. Mayor Haddock stated the general plan is only to be general. 34 Steve Simmons - stated he understands the trail system is to be extended to the south end of the city and there 35 are private landowners there that have a personal interest and wants to know how that is working and if there is 36 any quid pro quo going on where private landowners are saying we will do this if you do that for us. Is that 37 going on behind the scenes and how much of that is being presented to the general community? The survey said 38 40% of the residents were interested in trails, trails for whom and what kind of trails and accessibility? 39 Maureen Bushman stated the trails will be for everyone and different kinds of trails. The city has road easement 40 on both sides of the roads and safety, cost, and interest are all taken into consideration. The General Plan is not a 41

place to look for those details. Maureen Bushman thanked them for being here and showing an interest and

GENERAL PLAN DISCUSSION

Maureen Bushman stated the parks map is in the process of getting updated. There are some differences between the Utah County Parcel Map, Capital Facilities, and the city's current map. The names are confusing. The park at the northern part of the city on the city's Park and Open Space Map is listed as Sky Hawk Park, the Utah County Parcel Map and the Capital Facilities list it as Elk Ridge Meadows. It is divided into 4 parts totaling 16.7 acres. Does the commission think these pieces should have their own names? The northernmost piece isn't anywhere near Sky Hawk. This may be up to the city council to decide. Maureen Bushman numbered the parks 1-4 for discussion purposes. Goosenest Park (west of the roundabout) is 8.8 acres, Shuler Park by the city offices is 6 acres. The city has property on south Loafer Canyon Dr, called unofficially The Meadows which is being used for runoff mitigation which could be a nice park. The ravine along Loafer Canyon will be a future natural open space or park. The Capital Facilities Plan has the ravine as Loafer Canyon Park. There are 2 park areas in the undeveloped southern part of the city. The city adopted the standard set by the National Parks and Recreation Association of 5 acres of park space per 1000 people. The city currently has 30 acres of park space, the projected build out of the city is 8000 people, which would mean the city needs 10 more acres. The future proposed parks in the south end of the city would total 10 acres. These could be 25acre parks or 3 3.3-acre parks. It is not determined specifically what these parks could be at this time, and these are just proposed general areas. This would place parks throughout the whole city. The Capital Facilities Plan is also in the process of being updated so any changes made to the General Plan need to support the Capital Facilities Plan. A Park's Committee would determine the specifics, if there is no Park's Committee then it would fall to the Planning Commission. The city does not have a Parks Committee at this time. Ron Gailey stated the smaller town of Parowan received grant money, if they can get grant money Elk Ridge can get grant money. Grant money is available, but the city has to have a thorough plan in order to apply. Discussion ensued on the text of the parks section of the General Plan. Melanie Paxton stated conservation land/easements should also be included as types of open space. Maureen Bushman asked Royce Swensen to find out if park details should stay in the Capital Facilities Plan or if the General Plan should outline items more specifically and should there be a separate Park's Plan created. Would a Park's Plan be redundant? Emphasis needs to be made that parks are accessible to all residents, young, seniors, handicapped, etc. Parking needs to be prioritized. Mayor Haddock stated the current budget includes a parking area at the Sky Hawk Park near the southwest corner off of Cottontail Rd. Maureen Bushman stated the transportation map, trails map, zoning map, and parks map will be ready for the next meeting. The demographics data and the moderate-income housing info will hopefully be available in November. The Development Capacity Map does not belong in the General Plan and should be updated and put in the Capital Facilities Plan. An annexation areas map needs to be included in the General Plan, perhaps on the zoning map. The Planning Commission will go on a field trip to the current parks before the next meeting at 5:00 pm. Melanie Paxton stated she and Councilmember Willis went to the
