PLANNING COMMISSION ITEMS

1. LAYLA LOT A PLAT A SUBDIVISION

Joe Wilkens Developer stated this is a one lot subdivision a little over 3 acres. The cul-de-sac will be improved with access to the property to the west. The developer stated they opposed putting in a trail on the private property. The water lines coming down through the road and property will all be consolidated.

Greg Shelton had questions on the infrastructure on the property, sewer, manholes and the ability to get a vac truck to the sewer. Discussion ensued on whether the sewer should be private or city, if the sewer is city owned the city will need an easement. Calculation for the 100-year storm was requested and along with details on the swale. There was concerned about water, sewer and storm drain fitting in the city easement. Discussion ensued on the trail and that it is and has been in the General Plan and the placement, design and steepness of the slope.
